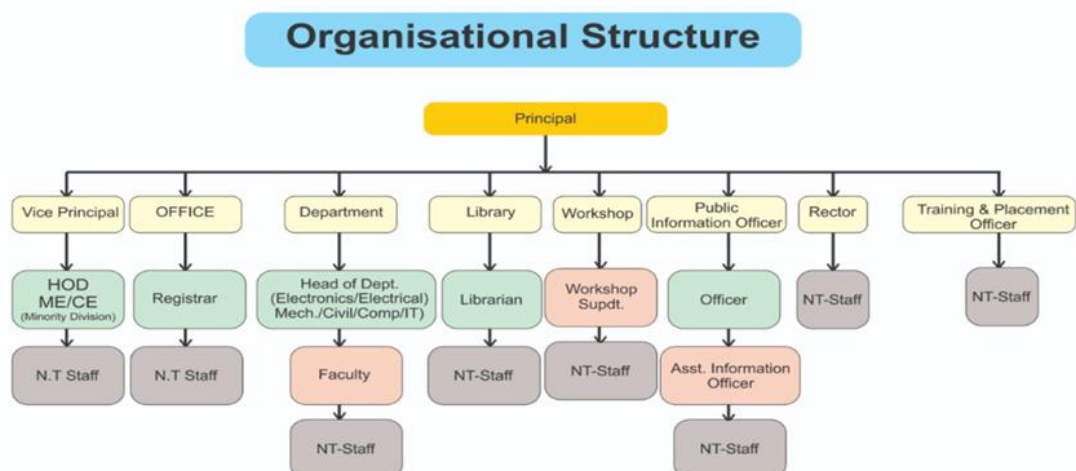

i. Organizational Chart



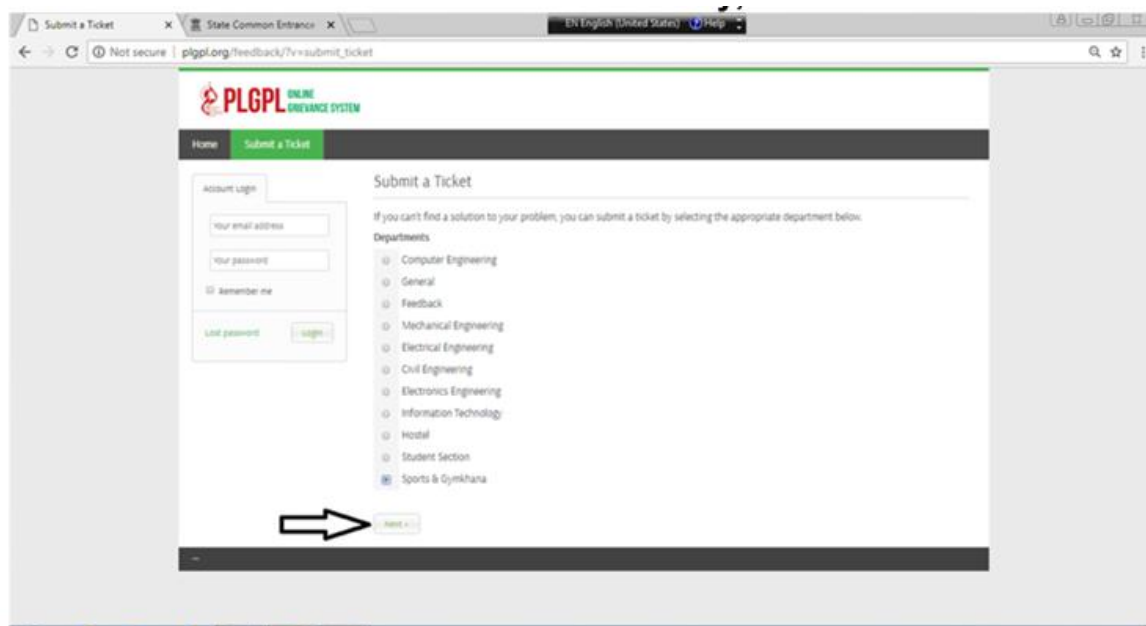

Situation and description of the land:- The area under acquisition is situated at village Latur near Bus Depot.

A W A R D

Introduction :- The Principal Muralidhar Lahoti Polytechnic Latur vide his letter No. PLGH/ENGINEER/64/582 dated 25th May, 1964 requested to initiate the land acquisition proceedings for the construction of Govt. Polytechnic building. Total area proposed to be acquired is 34 acres, from Sy.No. 192. The Land Acquisition proceedings are started under urgency clause and hence provision of section 4-A of the Hyd. Land Acquisition Act are not applicable to this case.

Publication of Notification: Notification under section 3(1) under urgency clause has been published in the Maharashtra Govt. Gazette supplement Part I, Aurangabad Division vide No. GR. 33.V. 1206/64 dated 27-8-1964 on page 629.

Final notification under section 5 has been published in Govt. Gazette supplement Part I Aurangabad dt. 19-11-1964 on page 905 vide letter No.

Accordingly Award Enquiry was conducted by fixing dates. Notices under section 7 and 8 were issued to all the interested persons and got served on 16-12-1964. In response to the above notice, landowners have notified any written statement regarding rate of compensation.

Ownership: Ownership of notified persons, have been proved from the Revenue record, furnished by the Tahsildar Latur.

Measurement: The land under acquisition has been measured by the Staff of D.I.L.R. and Acquiring Department. The area shown in J.M. report is treated as correct, for the purpose, of this Award, as the landowner have not objected for the same, during the land acquisition proceedings.

Situation and Description of the land: The land under acquisition is situated at village Latur. The land is kharif dry crop land and not of heavy B.C. soil, and is suitable for constructional purposes. It is adjacent to Sy.No. 188, 192 and 194 of Latur City. One Industrial Estate has been sanctioned for Latur City which is being established in Sy.No. 188 which is very near to Sy.No. 192. An area of 20 acres is being acquired

from Sy.No. 193 for the Industrial Training Institute at Latur. The said Sy.No. is just on the border of land under acquisition towards side. In front of these Sy.No. S.T. Bus Depot, has been constructed in Sy.No. 194. Some portion of Sy.No. 193 is also acquired for the Bus Depot. The distance between the Bus Depot and the land under acquisition is within a distance of one furlong, on Latur, ~~near~~ Ausa, road which is part of state Highway. The land is situated two miles away from the Railway Station. Besides, this the Dayanand College and Polytechnic old building are located within a radius of three furlongs from this land under acquisition. In the same way after a distance of two furlongs towards east of this land a Spinning Mill is being located on about eighty acres.

Thus it will be clear that the site under acquisition has got an importance in the development activities of Latur City.

Accommodation and Rent:

Does not arise.

Claims:

Notices under section 7 and 8 were issued and not served but the landowner have not submitted any claim or any rate of compensation.

Evidence by claimants

No documentary evidence has been filed by the claimants.

Evidence by Acq. Department.

The Acquiring Department has not produced any documentary evidence nor communicated any rate of compensation.

Valuation of land

In order to fix up the fair value of the land sale transaction of lands adjacent to the land under acquisition of Agril. lands for the last five years also are obtained from the office of the Sub Registrar Latur, which are mentioned in appendix "B" from perusal of appendix "D" it will be revealed that an area of 55 acres and 6 guntas has been sold at Rs. 53,957-00 i.e., average sale price comes to Rs. 900 to 1,000 per acre.

Sy.No. 189, 194 and 193 and 191 are adjacent to the land under acquisition. From Sy.No. 193, an area of 2 acres and 24 guntas and from Sy. No. 194, 3 acres and 4 guntas of land has been acquired for the construction of S.T. Bus Depot, in the year 1960. The total compensation awarded for the above acquired land is Rs. 196-07 and Rs. 2,062-34 respectively. Average sale price is Rs. 403/- per acre. This rate is applied in the year 1960. Copy of award is enclosed for a ready reference.

Similarly an area of _____ from Sy.No. 194 and from Sy.No. 193 has been acquired for construction of Latur Ausa Road. The compensation awarded for the above acquired area is Rs. i.e., ..



Additional information of sale transactions is also obtained and mentioned in appendix D. These transactions are of vacant sites from Agril. lands for the purpose of constructing residential buildings by individuals and the land under acquisition is similar to the area of Sy.No. 198 which is situated just on the border of Sy.No. 192. The average sale price of these non-agricultural sale comes to 23 paise, per sq. Ft.

This is all about the sale transactions, taken place in the last five years, but while fixing up the value of land under acquisition we will have to consider the period in which the acquisition has taken place. The price fixed for the Bus Depot and Latur Ausa road is fixed up in the year 1960 i.e., prior to 4 years of the present acquisition and therefore rate applied in these cases would be not be applicable to this case also. Further the rate of Rs. 1,000-00 per acre is also not justifiable and applicable, as from the Sy.No. 198, 36 acres and 32 guntas land has been acquired @ 12 paise per sq. ft. in the same period and the Award for the same is with the Govt. for approval. A rough sketch map is submitted for perusal of the situation and description of the land under acquisition.

It is also observed that at the time of Registration the villagers showed a less price in order to save stamp duty.

In view of the above facts, and considering the location of the land I fix the value of the land under acquisition @ 10 paise per sq. Ft. as a reasonable one as the land with all its quantities and importance is far away from the Railway station and the City. The rate applied to the acreage of Sy.No. 198 could not also be applied in this case as Sy.No. 198 is situated near to the City.

The area under acquisition is 34 acres and 2 guntas i.e., 15,20,244 sq. Ft. Total value of the land @ Rs. 0-10 paise per sq. ft. comes to Rs. 1,52,024-40 paise (One lakh fifty two thousands twenty four and forty naya paise) rate per acre comes to Rs. 4471 only.
